SCHOOL PARTICIPATION PERMISSION FORM

It is the responsibility of coaches to ensure that their students, parents, and judges are aware of and understand such tournament recording and livestreaming is permitted.
- 3. Our school shall be solely responsible for and complete any and all paperwork necessary to ensure compliance with applicable state laws regarding such recordings and livestreaming.
- 4. Our school agrees to all tournament rules, policies, and procedures found on the tournament's tabroom website. We agree that if at any time the tournament discovers a student, coach, judge, or school does not meet all the aforementioned criteria, the student(s) and/or school will be immediately disqualified from the tournament and forfeit any payments given to the tournament.
- 5. Our team will adhere to all requirements imposed by our school regarding their behavior, safety, and supervision. Neither James Logan High School nor the Tournament (collectively "James Logan") will be responsible for the behavior, safety, or supervision of our school members.
- 6. Our school releases James Logan from all legal and financial responsibility for any harm that our school, team members, or their property might suffer as a result of our school's failure to meet its obligations under this Agreement. Our school shall indemnify James Logan and hold James Logan harmless from (that is to say, our school agrees to pay or reimburse James Logan for) any costs, penalties, legal fees, or judgments that James Logan has to pay related to our school's failure to meet its obligations under this Agreement.
